Section 4: First aid measures

4.1 Description of first aid measures

Skin contact: take off contaminated clothes. Wash contaminated skin thoroughly with water and soap. Consult a doctor if disturbing symptoms occur.

Eye contact: contact an ophthalmologist if disturbing symptoms occur. Protect non-irritated eye, remove contact lenses. Rinse contaminated eyes with water for 10-15 minutes. Avoid strong stream of water – risk of damage of the cornea.

Ingestion: do not induce vomiting. Never give anything by mouth to an unconscious person. Consult a doctor, show the container or label.

Inhalation: consult a doctor, if disturbing symptoms occur. Remove the victim to fresh air. Keep warm and calm.

4.2 Most important symptoms and effects, both acute and delayed

Skin contact: possible redness, dryness, cracking, defatting.

Eye contact: redness, burning sensation, tearing, irritation.

Ingestion: possible abdominal pains, nausea, vomiting.

Inhalation: high concentration of vapours and mists may lead to irritation of mucous membranes of eyes and respiratory tract.

4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured. Symptomatic treatment.

Section 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: water fog, extinguishing powder, alcohol resistant extinguishing foam, carbon dioxide.

Unsuitable extinguishing media: water jet – risk of propagation of flame.

5.2 Special hazards arising from the substance or mixture

During combustion harmful fumes consisting of carbon oxides and other unidentified products of thermal decomposition may be produced. Do not inhale combustion products, it may cause health risk.

5.3 Advice for firefighters

Flammable liquid and vapour. Vapours of the product may form explosive mixtures with air. Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. Cool endangered containers with water fog from a safe distance. Do not allow residues of extinguishing agents to enter sewage systems. Collect used extinguishing media.

Section 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. Ensure that only the trained personnel removes the effects of the accident. In case of large spills, isolate the exposed area. Avoid eyes and skin contamination. Ensure adequate ventilation. Do not inhale product vapours. Use personal protective equipment Do not step on the spilled product – risk of slipping. Remove sources of ignition and naked flame, prohibit smoking

6.2 Environmental precautions

In case of release of large amounts of the product, it is necessary to take appropriate steps to prevent it from spreading into the environment. Notify relevant emergency services.

6.3 Methods and material for containment and cleaning up

Place the damaged packaging in an emergency container. Absorb the leakage with non-combustible liquid-binding material (e.g. sand, earth, vermiculite, universal binding agents, etc.) and transfer to appropriate waste containers. Treat collected material as a waste. Rinse off the residues with water with a mild detergent and ventilate the contaminated surface.

Section 7: Handling and storage

7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Do not eat, drink or smoke when working. Use personal protective equipment. Avoid eyes and skin contamination. Do not inhale product vapours. Ensure adequate ventilation. Before break and after work wash hands carefully. Keep the unused containers tightly closed. Protect from high temperature and direct sunlight. Work away from sources of ignition.

7.2 Conditions for safe storage, including any incompatibilities

Store only in tightly sealed containers in a dry and well-ventilated area. Store away from food and feed for animals. Opened container should be resealed and stored upright to prevent leaking. Store away from sources of ignition and direct exposure to sunlight.

Section 8: Exposure controls/personal protection

8.1 Control parameters

8.2 Exposure controls

Observe good occupational hygiene and safety practices. Ensure adequate general and/or local ventilation in the workplace. Do not eat, drink or smoke when using the product. If there is a risk of inflammation of the clothing on worker, showers and eye safety washers should be installed near the workplace.

Hand protection

Use protective gloves adequate to the performed task and suitable for the potential hazard. In case of short-term exposure wear the protective gloves with protection level 2 or greater (breakthrough time > 30 min). In case of long-term exposure wear the protective gloves with protection level 6 (breakthrough time > 480 min).
