## Section 4: First aid measures

### 4.1 Description of first aid measures

Skin contact: wash contaminated skin thoroughly with water and soap at the least 15 min. Take off contaminated clothes and wash it before reuse Consult a doctor if disturbing symptoms occur.

Eye contact: remove contact lenses. Rinse contaminated eyes with water for at least 15 minutes. Avoid strong stream of water – risk of damage of the cornea. Contact an ophthalmologist if disturbing symptoms occur.

Ingestion: do not induce vomiting. Rinse mouth with water. Never give anything by mouth to an unconscious person. Consult a doctor, show the container or label.

Inhalation: remove the victim to fresh air. Keep warm and calm. Consult a doctor, if disturbing symptoms occur.

### 4.2 Most important symptoms and effects, both acute and delayed

Negative effects of exposure during the normal and intended use of the product are not expected.

### 4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured.

## Section 5: Firefighting measures

### 5.1 Extinguishing media

Suitable extinguishing media: water spray, extinguishing powder, alcohol resistant extinguishing foam, carbon dioxide, water spray. Adjust extinguishing media to the materials stored in the product vicinity.

Unsuitable extinguishing media: water jet – risk of propagation of flame.

### 5.2 Special hazards arising from the substance or mixture

During combustion harmful gases consisting of carbon oxides, nitrogen oxides may be produced. Do not inhale combustion products, it may cause health risk. At high temperatures may occur evaporation and ignition of vapors of alcohol.

### 5.3 Advice for firefighters

Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. In case of fire cool endangered containers with water spray from the safe distance. Do not let extinguishing water to reach drainage system, ground and surface waters.

## Section 6: Accidental release measures

### 6.1 Personal precautions, protective equipment and emergency procedures

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. Ensure that only the trained personnel removes the effects of the accident. In case of large spills, isolate the exposed area. Avoid eyes and skin contamination. Ensure adequate ventilation. Avoid breathing vapours. Use personal protective equipment.

### 6.2 Environmental precautions

In case of release of large amounts of the product, it is necessary to take appropriate steps to prevent it from spreading into the environment. Material can be hazardous to the environment if released in large amounts. Notify relevant emergency services. Secure sewers, water installations and entrances to basements and other closed areas.

### 6.3 Methods and material for containment and cleaning up

Place the damaged packaging in an emergency container. Absorb the leakage with liquid-binding material (e.g. sand, earth, vermiculite, universal binding agents, silica etc.) and transfer to appropriate waste containers. Treat collected material as a waste. Rinse off the residues with water and mild detergent. Ventilate the contaminated area.

## Section 7: Handling and storage

### 7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Do not eat, drink or smoke during work. Wear personal protective equipment. Avoid eyes and skin contamination. Do not inhale product vapours. Ensure adequate ventilation. Wash hands before breaks and after work. Keep unused containers tightly sealed. Protect from moisture and high temperature. ## 8.2 Exposure controls

Observe good occupational hygiene and safety practices. The local exhaust ventilation is preferred, because it removes impurities from the place of their formation, preventing them from spreading. Do not eat, drink or smoke when using the product. Wash hands before breaks and after work.

### Hand protection

Use adequate protective gloves in case of direct contact with the product, e.g. vinyl gloves. Wear protective clothing.
